## **Bylaws of The Union Auxiliary**

### **ARTICLE I—NAME**

The name of this organization shall be THE UNION AUXILIARY of Union University, hereafter referred to as The Auxiliary.

### **ARTICLE II—PURPOSE**

The purpose of The Union Auxiliary is to provide a service arm to Union University through the provision of scholarships. The Auxiliary seeks to aid Union in its mission to operate as an excellence-driven, Christ-centered, people-focused, and future-directed institution. The Auxiliary also desires to lend special support to the lives of both international students and students of missionary families. The organization will strive to enhance the visibility of Union in the community by developing awareness that channels into active support.

### **ARTICLE III—MEMBERSHIP**

**Section 1.** Membership will consist of any women and men interested in the purpose of The Auxiliary. All memberships are renewable at the Fall luncheon each year and are recognized accordingly:

#### **Gift Recognition Levels:**

**Ethel Watters Scholarship Circle**—members who have made cumulative gifts to The Auxiliary totaling \$1,000 or more.

**Mary Jean Craig Scholarship Circle**—members who have made cumulative gifts to The Auxiliary totaling \$500 or more.

**Joyce Barefoot Scholarship Circle**—members who have made cumulative gifts to The Auxiliary totaling \$250 or more.

**Partners**—members making an annual gift of \$25 or more.

**Named Endowed Funds**—gifts of \$10,000 or more can be designated to establish a named endowment fund within The Auxiliary's scholarship gift program. All gifts for this purpose will be invested in an endowed account managed by the University. The net income allowable according to University policy, currently 5.5%, will be available annually for Union Auxiliary scholarship awards to eligible students. Awards will be made in accordance with the donor's intent and governed by the standard procedures established and administered by Union University's Financial Aid Committee in collaboration with The Union Auxiliary Scholarship Committee.

**Founder's Circle**—members who, through December 2000, made a one-time gift commitment of \$250 received a 10-year membership in The Auxiliary. These members are also offered the opportunity and are encouraged to contribute \$25 each year in support of The Auxiliary's annual scholarship gift program. Members of the Founder's Circle are included in one of the Leadership Gift Levels according to the cumulative total of their gifts designated for The Auxiliary.

**Section 2.** All Auxiliary members will receive *The Unionite* as published and regular newsletters of The Auxiliary, *The Difference*.

**Section 3.** Ninety percent of all membership receipts shall go directly into The Auxiliary Endowment Fund, or its designated endowment subsidiaries. Interest earned by this Fund or its designated subsidiaries shall be transferred regularly to The Auxiliary Operating Fund for distribution to scholarship recipients. Ten percent of membership receipts, including receipts to establish named endowed funds, will be deposited into The Auxiliary Operating Fund.

At the end of each fiscal year the Executive Committee shall review any unexpended funds in the Operating Fund not pledged for outstanding bills. Any

surplus funds may be transferred to The Auxiliary Endowment Fund or to some other Auxiliary project.

#### ARTICLE IV—OFFICERS

The officers of The Auxiliary shall be: President, Vice President for Programs, Vice President for Membership, Corresponding Secretary/Treasurer, and Recording Secretary/Historian. These will constitute the Executive Committee to meet on call of the President.

Officers appointed by the President or volunteers who desire to serve shall be designated as chairs of the following committees: Program, Scholarship, International Students, Students of Missionaries, Membership, Hostess/Events, Publicity, Nominating, and Bylaws. Each officer, with the exception of the Recording Secretary, shall serve with a committee of which she is the chairperson.

#### ARTICLE V—ELECTION OF OFFICERS

**Section 1.** A Nominating Committee of three members shall be appointed by the President at the Spring Membership meeting in even-numbered years to serve for two years. It shall present a slate at the Fall Membership meeting; nominations from the floor may be made with the prior consent of the nominee.

**Section 2.** Election, or appointment, is for a term of two years. Officers shall assume responsibility immediately following the Membership meeting in which they were elected and serve until their successors have been duly elected.

**Section 3.** Should an office become vacant before the incumbent's term expires, the President may appoint someone to fill the unexpired term.

**Section 4.** Terms of officers elected and/or appointed shall correspond to the 2-year terms of The Auxiliary officers. Officers may be re-elected for additional terms under the same election procedures.

## ARTICLE VI—DUTIES OF OFFICERS

**Section 1.** The President shall give general oversight to all the work of The Auxiliary and preside at all membership meetings and the Executive Committee, as well as have power to call special meetings of the Executive Committee. The President shall be *ex-officio* member of all committees except the Nominating Committee and shall have the power to appoint such special committees as may be necessary to conduct Auxiliary business.

**Section 2.** The Vice-President for Programs shall serve as Program Chairman and shall perform all duties of the President in the absence or incapacity of that officer.

**Section 3.** The Vice-President for Membership shall serve as Membership Chairman and shall search for ways to increase The Auxiliary's membership by use of special representatives in local churches and any other feasible avenues of income.

**Section 4.** The Corresponding Secretary/Treasurer shall keep accurate records of all Auxiliary memberships received and provide membership reports for the Executive Committee meetings. Through designated officers and staff this office is responsible for all monies received by The Auxiliary, shall pay out only such sums as are authorized by the Executive Committee, and shall keep adequate records of all receipts and disbursements.

**Section 5.** The Recording Secretary/Historian shall record and preserve the minutes of all Membership meetings and Executive Committee meetings. This officer shall also serve as the Historian to be responsible for preserving the history of The Auxiliary in whatever form approved by the Executive Committee. These may include printed programs, news items, photographs of personalities, and activities of The Auxiliary.

The following committee chairs are also on call by the President for any Executive Meeting deemed essential.

**Section 6.** The Program Chair, in consultation with the President, shall take the initiative in planning and enlisting program personnel for the Spring and Fall Membership meetings.

**Section 7.** The Scholarship Chair shall be responsible for the selection of scholarship recipients as funds and/or applicants are available and for service to scholarship recipients as needed during their enrollment in the University. The Scholarship Chairperson, the University Financial Aid Officer, The Auxiliary President, and the person (or persons) for whom the specific scholarship(s) is (are) named (if honoree so desires) shall comprise the committee to select scholarship recipients.

**Section 8.** The International Students' Chair shall welcome international students and their families to the campus on behalf of The Auxiliary and assist in meeting the needs of both groups throughout the year.

**Section 9.** The Students of Missionaries Chair shall endeavor to minister to missionaries' children during their study at the University, both to their needs and to their encouragement.

**Section 10.** The Membership Chair shall be the same person as the Vice-President for Membership, whose duties are in Section 3.

**Section 11.** The Hostess/Events chair shall be responsible for providing hospitality at Spring and Fall membership meetings.

**Section 12.** The Publicity Chair shall publicize the work and membership meetings of The Auxiliary through whatever media resources are available.

**Section 13.** The Bylaws Chair, a long-time member of the Union University community, with the President of The Auxiliary and any other members needed shall articulate in writing the official Bylaws of The Auxiliary.

## ARTICLE VII—AMENDMENTS OF BYLAWS

Amendment by Membership. These Bylaws may be altered, amended, or repealed and new Bylaws may be adopted by a majority vote of The Union Auxiliary members present at any Membership meeting. No such amendment shall alter or affect the relationship between The Union Auxiliary and Union University without approval of the President of the University. Such amendments shall be effective immediately upon adoption.

## ARTICLE VIII—GENERAL PROVISIONS

**Section 1.** Gifts—The Auxiliary shall be authorized to receive gifts, legacies, and bequests for the benefit of the University in accordance with the Internal Revenue Service guidelines prescribed for the University.

**Section 2.** Reimbursements—Executive Committee members and all committee members shall be entitled to reimbursement for actual, reasonable expenses incurred in the implementation of activities of the Auxiliary provided such expenses have been approved by the President.

## ARTICLE IX—PARLIAMENTARY AUTHORITY

The Auxiliary shall be governed by *Robert's Rules of Order, Newly Revised* in all cases to which they are applicable and in which they are not inconsistent with the Bylaws.
